## **TABLE OF BUCKLAND MONACHORUM CEMETERY FEES - FROM 1<sup>ST</sup> APRIL 21**

*(Adopted at the 26<sup>th</sup> January 2021 Council meeting)*

The fees fixed and settled under the Local Government Act 1972 by the Parish of Buckland Monachorum are as follows:

### **1. Purchase of Graves/ cremation plot (50-year Exclusive Right of Burial):**

<b>a)</b> Purchase of grave	420.00	840.00
<b>b)</b> Purchase of cremation plot	225.00	450.00
<b>c)</b> Additional premium for pre-purchase of grave/cremation plot	200.00	400.00
<b>d)</b> Transfer of right of burial	50.00	100.00
<b>e)</b> Where a Statutory Declaration is required for Transfer	100.00	150.00
<b>f)</b> Premium for additional period of 50 years* * only one additional period of 50 years may be purchased	400.00	800.00

### **2. Interments**

<b>a)</b> For first interment of a coffin in an earthen grave, (double depth)	150.00	450.00
<b>b)</b> For second interment of a coffin in an earthen grave	150.00	450.00
<b>c)</b> For interment of an urn or casket containing cremated human Remains	125.00	375.00
<b>d)</b> Weekend burials (if possible – not to clash with Church Services etc. & if grave digger is available)	300.00	600.00

### **3. Headstones**

For the right to erect a memorial stone on a grave in respect of which the exclusive right of burial has been granted. Period of Right to erect a memorial is 50 years

<b>a)</b> Headstone (grave only) and first inscription	150.00	300.00
<b>b)</b> Additional inscription(s)	40.00	80.00

### **4. Commemorative Benches**

To install concrete base 5ftx3ft and 10-years maintenance	450.00	600.00

### **5. Scattering of ashes:**

Ashes may be scattered on a grave where an exclusive right of burial has been granted and correct legal ownership of said right of burial properly established.

**A minimum donation of £75.00 to be made to cemetery maintenance.**

### **The definition of a resident for the purposes of the fees and charges associated with the Cemetery:**

1. A person who is or was, until the time of death, living continuously in the Parish, or who was living continuously in the Parish up to 12 months previous to the purchase of a plot.
2. A person who was living continuously in the Parish, but who left to take up residence in another location for the purposes of being cared for.
3. A second interment in a plot where the person is the spouse, partner or sibling of a resident already interred in the plot.
