## 312/18 | NEIGHBOURHOOD PLAN – UPATE WITH REGARD TO CONSUTATION (CLLR CHEADLE)

RC gave an update on the Neighbourhood Plan. The Dartmoor National Park consultation will be on Tuesday 11<sup>th</sup> Dec between 3pm and 6pm at Yelverton War Memorial Hall. RC has spoken to DNP and the council can consult at the same time. DNP have four areas that will be being considered.

After the consultation it will be necessary to update the plan and get approval from West Devon Borough Council. It is hoped that the Parish Councils Neighbourhood Plan will be in place by Easter 2019.

#### 313/18 TO DISCUSS AND AGREE REPLACEMENT AND POSSIBLY NEW PLAY EQUIPMENT WITHIN THE PLAY PARKS

GB is going to speak to the school and Jane (Beehive Nursery) about what is needed in the playpark. SW talked about her plan for new equipment at Crapstone playpark. If possible SW would like to plan a large scheme and fund the project with Crowdfunding or a similar scheme. There were no objections to this being carried out and it was agreed that GB and SW will work together.

## 314/18 TO DISCUSS AND AGREE MAINTENANCE OF THE PROPOSED BRIAR TOR FOOTPATHS.

The developers have confirmed that they will build the paths. What is required is the assurance that the paths will be maintained by BMPC. After a short discussion it was **AGREED** that BMPC will accept responsibility for maintenance of the path once the standard and construction of the path has been confirmed.

#### 315/18 TO DISCUSS HGVS GOING THROUGH CLEARBROOK AND NOT USING PROPER ROUTE. (CLLR ALLAN)

Clearbrook has become a route that HGVs use on a regular basis. Unfortunately the route is not appropriate and they often get stuck especially on the bridge. This happens about every 6 weeks. This results in there being a huge amount of resource put in to free the HGVs. RA has taken some steps already. RA was advised that DCC Highways department may be able to offer support. RC will liaise with both RA and DCC about the issue.

## 316/18 TO DISCUSS AND AGREE TRUSTEES FOR DRAKE TRUST MILTON COMBE

Under the terms of the Trust Document BMPC are responsible for the appointment of the two trustees. Val Bolitho is currently a trustee. The other trustee is Gordon Stansbury but he would like to stand down with immediate effect. He would like to nominate Dr Jeremy Clark to serve as the second trustee. It was **AGREED** BMPC would support the nomination and Dr Jeremy Clark will be the second trustee.

# 320/18 TO RECEIVE A REPORT FROM THE WDBC CLLR FOR THIS WARD (CLLR CHEADLE)

RC reported that he has spoken to WDBC about the closure of the public toilets at Bedford Bridge and Yelverton. If BMPC take on the running of the facilities or pay WDBC to continue to run them this will mean a significant increase in the precept.

## 322/18 HIGHWAY MATTERS AND REPORTS OF MINOR REPAIRS

There are problems in Milton Combe with people parking and blocking access. There are concerns that there would be limited access for emergency vehicles. RC AGREED to speak to DCC Highways local officer Tom Lee, concerning the issues.

SW commented with regards to the funding for the extra verge cutting that Pete Badge has undertaken this year. DCC paid £600 towards the extra work and £500 was obtained from sponsorship. If BMPC get the same again next year it would only directly cost £100.

# 323/18 TO AGREE FUNDING FOR DRAINAGE WORK PREVIOUSLY CARRIED OUT BY THE LENGTHSMAN.

SW requested funding for drainage work to be carried out in Buckland Monachorum, Milton Combe and Crapstone. This was work that was previously carried out by the lengthsman. The cost would be approximately £560.

It was AGREED that this work could be carried out.

# PARISH PATHS (P3) AND OTHER FOOTPATH MATTERS.

#### To discuss and agree required funding for replacement footpath fencing. (Cllr Woollacott)

SW reported that there are two footpaths that require a small amount of work. Footpath No6 has two fence posts that require work at a cost of £70.

Footpath 19 requires an area between the two metal gates to be levelled.

It was AGREED that the work could be carried out.

## 325/18 TO DISCUSS THE CREATION OF A BANK IN CRAPSTONE WETLAND MEADOW.

A neighbour of the Crapstone meadow has requested if they are allowed to build a small bank to prevent run off into their garden. The resident will cover the cost.

It was **AGREED** that this would be allowed.
